develop and implement integrated strategies for the Social and Solidarity Economy sector, focused on the economic and social development of the citizens and territories, responding to basic needs of the most vulnerable categories in the Moroccan population. The focus must be on a type of entrepreneurship that deploys principles that value equality, innovation, intergenerational solidarity, social act and ethics, above all purely economic element.

The fight against poverty, the bedrock of the Social and Solidarity Economy (SSE)

The political and economic transition initiated since the nineties gives priority to the fight against extreme poverty by crossing two dynamics.

On the social front, a new Moroccan society has its roots in the combined effect of the fundamental reforms of the family code and the great operation of national reconciliation, alongside the constitutional reform of July 2011, which paved the way for the consolidation of the democratic process and an increased sharing of powers and responsibilities between the Monarchy and the Government Executive.

At the level of the economic strategy, the policy of major infrastructure works, the liberalization and stimulation of foreign direct investment suggested a better anchoring of the Kingdom in its international environment. The effort also concerned all areas that influence the decision and attraction of investors with the launch of major projects (TGV - Tangier Med urban real estate) and the creation of specialized institutions covering areas such as the credit guarantee, the taxation, the alleviation of administrative procedures, the modernization of the financial sector, the labor market, the regulation of competition, support for SMEs and business ethics. Creating such an environment for FDI enabled, in turn, to respond to a fundamental dimension of the establishment of a SSE ecosystem that consists of attracting and retaining contributors, mainly firms, which often intervene on several levels: Financing, accompaniment ... Morocco is also ranked sixtieth (60) in the Doing Business ranking of the World Bank in May 2018, out of a total of 190 countries; and is the second highest ranked country behind the United Arab Emirates for the Middle East / North Africa region. This ranking highlights the Kingdom's ability to attract foreign investment as well as its environment that is conducive to business creation.

On another level, starting from the fact that digital transformation, reducing the digital divide is an important prerequisite for stimulating a dynamic of social entrepreneurship through connected objects or Internet of Things (IoT) that permit responding to needs as basic as those of health and education. According to the National Telecommunications Regulatory Agency (ANRT), Internet was established in Morocco to more than 23.77 million subscribers at the end of 2018 and performing a penetration rate of 67.5% against 2% in 2002.

On this momentum of connectivity, the Kingdom of Morocco has given great importance to road infrastructures. The road network, thus, ensures 90% of people's journeys and 75% of goods transport, contributing to the balanced development of the territory and making it possible to support investments and the opening up of rural populations. His Majesty the King has, in this respect, made innumerable visits to remote areas of the national territory in order to stimulate a real dynamic of opening up and connection to the rest of the regions better off in terms of basic infrastructure. The Mohammed V Foundation for Solidarity, under the effective leadership of HM King Mohammed VI, also plays a major role in the sustainable development of these territories and for the most fragile citizens living there. The Foundation has, thus, developed recognized know-how in terms of targeting to complete basic infrastructure projects, such as drinking water supply or connection to electricity.

In fact, electrification has, in turn, given impetus to the dynamic of opening up. Indeed, the global rural electrification program (PERG) has achieved a real prowess in 22 years, with an increase of 18% in 1995 to 99.62% at the end of October 2018. This rate should increase to 99.85% in 2020. This network providing driving force is essential to industrial, agricultural and social development. Electrification makes it possible to contribute to the servicing of social entrepreneurship projects in order to intensify the contribution of the rural environment in the development process.

The economic and social integration of women and Moroccan youth: a strategic priority for HM The King.

It is important to underline that Morocco has for decades been part of a voluntary process that has enabled women and young people to gradually integrate different sectors of public, political, socioeconomic and cultural life. Thus,

in the perspective of a democracy of proximity and participation meeting the legitimate aspirations of the Moroccan people, HM King Mohammed VI has made the promotion of the situation of women and youth a national strategy.

Regarding women, under the leadership of His Majesty Mohammed VI, several advances have been made in this area, crowned by the major contribution of the 2011 Constitution, which clearly affirmed the equality of men and women in their civil, economic, political, social and cultural rights and freedoms. Various structures and tools have. hence, been put in place to ensure gender equality and combat all forms of discrimination, accordingly meeting the royal guidelines in this area.

At the economic level, the National Initiative for Human Development (INDH) enables thousands of women to realize their entrepreneurial spirit through

the creation of microenterprises and cooperatives around incomegenerating activities. This reigning project of the INDH was able to demonstrate the dynamism of Moroccan women and the success of their business creation projects. Thus, out of more than 15,000 Moroccan cooperatives, around 2,800 are feminine.

Youth, meanwhile, represents more than 30% of the Moroccan population and has always been at the forefront of the demand for change and modernization of society. His Majesty the King has continually sought to associate the youth in the political debates surrounding constitutional reforms. In this context, the new Constitution of 2011 reflects the richness and diversity of the proposals of the associative movements with the creation of the Consultative Council of the Youth and the associative action, in particular, in relation with the importance of the contribution of the youth to the process of democratization. Youth training and qualification infrastructures, libraries, information and communication technology spaces, and other income-generating activities were provided as part of the Royal attention to social and solidarity entrepreneurship and its axial role in the integration of Moroccan youth. The Mohammed V Foundation for Solidarity has also developed a new approach to the integration of young Moroccans into the working life; by providing them with qualifying vocational training, while giving them the benefit of accompanying measures in order to awaken their entrepreneurial spirit and encourage them to create their own production units.

Promoting Social and Solidarity Entrepreneurship: Royal Attention and Interest in Innovation

The Royal Vision for Development has always focused on the fact

that innovation is a key factor of national competitiveness and has advocated spreading a culture of innovation and entrepreneurship among the Moroccan society. This is illustrated by the royal initiatives to encourage dynamics involving companies, research and training centers and institutions, to develop and stimulate the emergence of innovative collaborative projects. For this, Morocco has already launched in 2012, under the leadership of HM the King, several major

territorial space by improving its attractiveness and, thus, strengthening its economic competitiveness.

In this overall framework of economic and social development of Morocco, Social and Solidarity Entrepreneurship takes its place. And this, through innovation in the ideas and mechanisms advocated by HM the King, and His calls to strengthen the productive capacity of actors of this type of entrepreneurship through the

projects for the establishment of technological infrastructure and innovation, particularly in the framework of the Morocco Innovation Strategy, inspired by the Royal High Orientations.

Moreover, it is essential to highlight the global and integrated nature of the Royal Guidelines in relation to the promotion of the economic and social development of Morocco, and this by placing this vision in the framework of advanced regionalization and the laws governing the Regions. HM the King has always called for the Regions to use their powers to promote the integrated and sustainable development of their



Minister of India, Mrs. Sushma Swaraj visited Morocco from February 17 to 18, 2019. In a meeting with Kingdom's Minister of Foreign Affairs and International Cooperation, Mr. Nasser Bourita on February 18, both ministers discussed ways to enhance bilateral cooperation in a number of areas including defence and security, counterterrorism and trade and investment.

India's visiting Minister handed over to Minister Bourita a letter from Prime Minister, Mr. Narendra Modi addressed to HM King Mohammed VI. "The then External Affairs Minister of India, Mrs. Sushma Swaraj handed over a letter from PM Narendra Modi, addressed to His Majesty the King of Morocco, to Foreign Minister of Morocco Nasser Bourita. This was in response to His Majesty's letter," Kumar said.

Minister Swaraj called on Head of Government of Morocco,



Mr. Saad-Eddine El Othmani. They discussed steps to expand ties, specially by deepening the strategic content through cooperation in areas such as counterterrorism, Kumar said.

"Swaraj called on President of House of Representatives of Morocco Parliament, Mr. Habib El Malki. Discussion on expanding cooperation between Parliaments of both countries as a way to further consolidate our cooperation," he said in a tweet. Swaraj also laid a wreath at the Royal Mausoleum in Rabat, paying her respects to the Monarchs of Morocco.

India and Morocco signed four MoUs following the delegation-level talks between Minister Mrs. Swaraj and her Moroccan counterpart Mr. Bourita in Rabat.

Briefing media after the meeting, Mrs. Swaraj said, the MoUs include setting up of Joint Working Group on Counter Terrorism, Cooperation in Housing and Human Settlement, Reciprocal facilitation of procedures for issue of Business Visa and Cooperation in Youth Matters.



Morocco a Key Partner of India to Fight Terrorism, Inks MoU for Co-operation in Outer Space

orocco is emerging as a key counter-terror and de-radicalisation partner for India in North Africa. The two countries inked a MoU on 'Cooperation in peaceful uses of Outer Space'.

It was signed in the presence of the then Defence Minister Mrs. Nirmala Sithraman and the visiting Minister Delegate to the Head of Government in charge of the National Defence Administration of Morocco, Mr. Abdellatif Loudiyi. In 2015 the two countries decided to elevate bilateral ties to a Strategic Partnership and have been working to include new areas of cooperation to the partnership such as space, military cooperation besides the traditional ones of fertilisers, chemicals, automobiles, renewable energy and construction.

As reported earlier "Indo-Moroccan relations have been strengthened, particularly after the historic visit of King Mohammed VI to New Delhi in October 2015 as part of the third India-Africa Forum Summit."

Morocco, fast emerging as North Africa's economic leader and a major source of phosphates for India, which is the largest Asian recipient of Moroccan public investment. The return of Morocco to the African Union in 2017 after three decades added further momentum to Africa-India relations.

orocco's experience in doing business in Africa will benefit Indian operators looking to increase their investments in Africa.

Africa is the primary beneficiary of Moroccan direct investments, thanks to the development of partnerships and the royal interest in the continent's development, said Moroccan Minister of Industry, Investment, Trade, and Digital Economy, Mr. Moulay Hafid Elalamy.

In an interview with Maghreb Press Agency (MAP), Mr. Elalamy stated that Morocco invested MAD 37 million in Africa from 2013 to 2017, thanks to partnerships and the organization of the national economy towards South-South cooperation, in accordance with King Mohammed VI's vision.

The Minister stressed that Morocco is now one of the top African investors of the Economic Community of West African States and the Economic Community of Central African States. Mr. Elalamy added that the notable growth of Moroccan investments in Africa in the last decade is due to Morocco's strong commitment to developing the continent.





n an interview to Morocco World News, Mr. Elalamy said that "Morocco's presence in the Africa-India conference is extremely important following meetings with leading Indian companies having high investment prospects."

"Morocco is now a real platform at the African level, having free trade agreements with 60 countries, making Morocco a real production and export platform," he highlighted.

The Minister also spoke of Morocco's long-standing business relationship with India. "Our Indian friends have joined other American, Chinese, and European investors already established in Morocco," he said.

He added, "Some Indian companies are well established in Morocco. They know very well how our country works and they







aspire to strongly develop their activities further."

The Minister evoked the lengthy presence of the Indian group, Tata, in Morocco and the inauguration of the first plant by India's Varroc group in the Tangier free zone on February 26.

Mr. Elalamy said, "The Varroc group is of Indian origin in terms of capital and is active in the automotive sector and manufactures lighting."

The Minister appeared optimistic overall about the Indian-Moroccan partnership's future, saying, "We have many things to do together and I think the future will bring us more important partnerships than we have had in the past."


He noted that HM the King carried out 50 royal visits to more than 30 countries since 2000 and signed more than 1,000 agreements.

Considered one of the Indian Navy's most state-of-the-art vessels, the INS Tarkash is currently part of the ongoing peace mission to the Mediterranean. The mission is intended to further cement India's relations with Morocco, among other countries.

During its stay in Tangier's Port, a number of Moroccan officials
— including high-ranking naval officers — visited the vessel. The
Tarkash has also planned to participate in a number of activities
with the Royal Moroccan Navy, including a Passage Exercise at sea.

For years India has been working to establish stronger relations with Morocco, and the Tarkash's stay in Tangier is another step in strengthening the bond between Morocco and India.

Beginning with the India-Africa Forum Summit in New Delhi, bilateral relations between India and Morocco have drastically improved over the years, exemplified by 19 ministerial visits between the two countries since the forum in 2015.

In 2018-19, trade between the two countries surpassed US\$ 1.8 billion, with the commercial relationship between Morocco and India being the best it has ever been.

With both Morocco and India continually becoming more powerful players in international affairs, each country has seen the relationship as a mutually beneficial opportunity. Relations between the two countries will remain cordial for the foreseeable future.

India and Morocco's New Cooperation Areas: Focusing on Security and Preventing Violent Extremism

Introduction

With India looking more towards Africa as a home for sustainable partners, it is also looking at diversifying the areas of collaboration with several African countries, especially with established diplomatic relations based on mutual understanding, tolerance and respect. Since then, the two countries have enjoyed fruitful relations that materialized in various sectors. in the framework of the Non-Aligned Movement. The relationship evolved to include further collaboration in the fields of agriculture, trade and food security amongst others. Indeed, the traditional areas of

Tourism Authority in India. Morocco was one of the main partners to walk India towards its green revolution. By providing fertilizers that are adaptable to the needs of Indian soils, Morocco helped India walk faster towards achieving a green revolution.

While we could consider that the collaboration between India and Morocco has reached an optimal level, both countries are looking at taking the collaboration further. Looking at assets from both countries indicates that there is room for upgrading the type of mutual engagement.

Morocco enjoys an advantageous status of being one of the most stable countries in North Africa. In the wake of increasing security challenges in North Africa but also in the Sahel region, Morocco continues to play a key role in enhancing regional stability. Its soft power approach to countering violent extremist discourses and smart management of social demands fueled its image a politically stable country. Indeed, Morocco's approach to preventing violent extremism (PVE) and countering violent extremism (CVE) is based on three multidimensional pillars. First, intelligence gathering. Second, socio-economic reforms. Third, the reform of religious schools. In addition, Morocco is already partnering with the United States of America, France and Spain, -amongst others, in the field of countering and preventing violent extremism.

Furthermore, Morocco's Central Bureau of Judicial Investigation (BCIJ) holds positive records that reinforce Morocco's position as a leader in countering radical discourse and deconstructing violent extremist discourses. The BCIJ, created in 2015, has been actively working on dismantling some of the terrorist cells and arresting terrorism-

related suspects. It has also worked with partner countries on intelligence sharing to prevent violent extremist attacks.

Similarly, we can praise India's approach in the fields of defense and security. Indeed, India has

transnational threats, it is essential to reinforce the cooperation between countries to capitalize on each other's experience.

There are growing interests from both sides to leverage on each country's expertise. Both countries

Whether on a side or another, both countries have remarkable experience on which they can leverage to reinforce their collaboration in the security field. Given the multiplication of complex new threats, including

have a growing interest in security issues as they are located in the middle of a volatile environment and face threats to their internal as well as external stability. The issue of violent extremism cannot be dealt with at the national level only but it also requires a joint multidimensional approach.

Furthermore, cyber threats are increasingly worrying and are part of the tools for asymmetric wars. Despite countries efforts to improve their IT security, cyber-attacks and security breaches persist. Besides, the rapid evolution and sophistication of cyber-attacks can threaten the digital transformation which usually includes highly sensitive data. The rapid deployment of

digital technology puts digital infrastructures at risk. Since cyber-attacks are transnational, cooperation for preventing them is increasingly important.

From High-Level Visits towards Concrete Actions

Since His Majesty King Mohammed VI's visit to India in 2015 on the occasion of the Africa-India Summit, several agreements were signed between both countries. While the emphasis was mostly on food security, security, including cyber, emerged as priority cooperation area. Following His Majesty King Mohammed VI visit, the two countries elevated bilateral ties to the level of a strategic partnership.

Since 2018, there are more signs that India and Morocco are looking to expand their collaboration to the security field. Given their shared challenges, collaborating on security aspects is of utmost importance to secure

joint patterns of peace and prosperity. Morocco stands out as one of the top security partners for India in North Africa. This new collaboration on security matters will feed the India-Morocco partnership.

In September 2018, Deputy Minister for Administration and National Defense, Abdeltif Loudyi met with Indian Minister of Defense, Nirmala Sitharaman in New Delhi. The discussions covered new areas of mutual interest. Indeed, the two ministers addressed issues of national defense, maritime security and defense industry. To assert their cooperation in those newly identified fields, the two countries signed two MoUs to collaborate in areas of defense and security, including cybersecurity. The first MoU signed by the Moroccan Computer Emergency Response Team and its counterpart aims at deepening cooperation in the cybersecurity field. The two

parties agreed on exchanging knowledge to cope with securityrelated incidents. The second MoU covered the peaceful uses of outer space. This MoU which comes with more technical cooperation aims at deepening cooperation in the science of space and satellite technologies. The collaboration on space comes as an additional step in tackling transnational issues that affect both India and Morocco. With their respective experiences, India and Morocco can highly benefit from joining efforts in preventing external threats. Both countries also agreed to collaborate in shipbuilding and manufacturing support. Two months later, Indian Minister of State for Home Affairs, Kiren Rijiju, and Morocco's Minister of Justice, Mohamed Aujjar signed an agreement on mutual legal assistance and to create a joint legal framework both for tackling crimes and preventing acts of violent extremism. The collaboration between both



countries looks at identifying, investigating and prosecuting crimes as well as any terrorism-related activities. It also includes an agreement for extradition measures.

In February 2019, the Indian Minister of External Affairs, Smt. Sushma Swaraj was on a two-day visit in Morocco where she met with the Moroccan Minister of Foreign Affairs and International Cooperation. The visit was translated into the signing of four cooperation agreements.

of funding of violent extremisms and ending the recruitment by violent extremist groups. They have also agreed to reinforce their collaboration in the framework of multilateral security bodies.

Since then, Morocco has provided India and Sri Lanka with relevant information days before the Sri Lankan terrorist attacks. Morocco's Central Bureau of Judicial Investigation service has identified the identity of nine suicide bombers of the attack on 21 April 2019. Thanks

the Royal Moroccan Navy and the Indian Navy organized joint activities such as a special passage exercise at sea. This exercise took place on the sidelines of the Indian Naval Ship Tarkash threeday visit to Tangier. The choice of Tangier highlights India's recognition of Morocco's strategic positioning in the Mediterranean.

Conclusion

In sum, including security in the cooperation agenda of Morocco and India is a way to upgrade

One of them aims at countering terrorism through joint efforts. The two ministers discussed the possibility of setting up a working group on security cooperation and information sharing. This collaboration reaffirms the need for cooperation on issues affecting countries globally. The issue of violent extremism cannot be dealt with at the national level only but it also requires a joint multidimensional approach. Indeed, Rabat and New Delhi will be working together on various aspects such as identifying sources

to its intelligence data, it was able to provide Sri Lanka with relevant information to conduct an operation in Colombo aiming at eliminating terrorists who were planning a second round of attacks after the Easter Sunday Bombings. In general, Morocco holds a substantial database about ISIS and some of its network.

Beyond intelligence sharing and cooperation on preventing acts of violent extremism, there was also a rapprochement with the Royal Moroccan Navy. In July 2019,

the relationship between both countries. This new field of cooperation entails benefits not only to the two countries but also to their respective regions. Furthermore, it will help India and Morocco undertake more concrete actions to prevent and react to global issues.







Tanger Med 2 to Become the Top Container Port in the Mediterranean

he Crown Prince of Morocco, HRH Moulay Hassan, son of HM King Mohammed VI, inaugurated Tanger-Med 2 of Tangier port, which will enhance the Kingdom's position in the Euro-Mediterranean region.

Tanger-Med 2 now has the largest Mediterranean port capacity and by connecting Morocco to 77 countries and 186 ports, the port contributed to the location of Morocco on the international maritime scene, announced Head of the Tanger Med special agency Fouad Brini. "Tanger today represents the top port in the Mediterranean in terms of capacity."

Morocco is now in the 17th place according to the United

Nations Conference on Trade and Development (UNCTAD), Brini said, adding that: "That's something to be proud of."

Brini pointed out that the port provides Morocco with world-class infrastructure in Gibraltar Strait and makes the Kingdom a regional and industrial player of the first level in Africa and the Mediterranean. He added that the visionary decision of the King of Morocco to launch the studies and construction of Tanger-Med 2 enabled Tangier port of tripling its capacity from 3 million to 9 million containers per year.

The Head of the agency added that in 2018, Tanger-Med 1

handled 3.4 million containers, which enabled it to be located as the first port in Africa, ahead of Egypt's Port Said on the Suez Canal and Durban in South Africa.

Tanger-Med is the first African port to be labeled EcoPort, part of the main environmental initiative which features equipment that respects the environmental standards of the European Maritime Ports Organization.

Brini noted that the momentum of development will continue for a new investment program worth \$900 million, adding that this investment programme aims at keeping pace with the growth of Moroccan industrial and agricultural exports, through expanding port processing capabilities and creating new facilitation zones.

This dynamism will contribute to improving the logistics competitiveness of the African continent and confirm Morocco's integration in the world's leading logistics corridors by enabling Tanger-Med to be located within the world's top 20 container ports, explained Brini.

He recalled that 12 years after the actual launch of the project, the innovative model of the Tanger-Med Agency's governance is systematically brought up in the best global practices.

A.P. Moller Maersk, CEO Morten Engelstoft said that Tanger-Med is one of the most developed ports within the port network in which the group operates. He added that this port platform is one of the strategic centers within the global network of A.P. Moller Maersk.

Engelstoft noted that Tanger-Med is a leading port with a very advanced technology that offers effective and safe

solutions. He praised the extraordinary business climate in Morocco, stressing that Maersk reaffirmed its commitment and trust in country.

Tanger-Med 1 & 2 port director Rachid Houari stated that the port put Morocco in the category of the world's great marine countries.

He also pointed out that Morocco has become an inevitable destination, and Tanger-Med is an indispensable port. The extension is the result of nine years of work and 1.3 billion euros of public funding along with an equivalent amount pumped in by private investors, explained Houari.

Morocco is hoping to increase Tangier 2's container handling capacity to 4.5 million TEUs by the end of the year, matching the capacity of Port Algeciras in southern Spain.

Morocco is preparing to operate new quays at the port of Tangier, which will turn it into the biggest port in the Mediterranean in terms of container capacity and a magnet for investment and manufacturing industries.

With the expected development of logistics facilities and the rise in the number of off-shore companies in an adjacent free economic zone, it is believed that the Tanger Med 2 port will become the primary port destination in the Mediterranean. It would surpass the two largest commercial ports in the region — Algeciras and Valencia in Spain.

"The inauguration of the Mediterranean port of Tangier 2 will be indicative of the success of the handling and services policy that Morocco is trying to implement in a range of free zones," Mohamed Yaouhi, a Professor of Economics at Rabat University, said in a statement.

"The new port will be able to handle a larger number of containers coming from different ports of the world as well as facilitate the transit of passengers."

Yaouhi said Morocco is taking advantage of its strategic location and of Moroccan King Mohammed VI's support for free-zone ports to aid economic and social development.

For the handling and services policy to succeed and for Morocco to transfer industry and technology, Yawhi said local companies need to strike partnerships with international firms in the neighbouring industrial zone in industrial, logistics and service activities.

The port of Tangier, near the Strait of Gibraltar, has undergone a major expansion in the past two years. Since being equipped with three of the largest container cranes in the world last February, the port has been working at full capacity.

The port's website states that Tanger Med 2 represents the third stage of the development of the Tangier-Mediterranean port complex, along with Tanger Med 1, the passenger terminal and the small boat harbour. Port facilities are managed by APM Terminals, a joint venture between Danish Maersk, German Eurogate and a local company.

Tanger Med 2 provides a platform for exports from local production plants of automotive parts for French automakers such as Renault and Peugeot. Port authorities hope to capitalise on the port's location on the western side of the Mediterranean coast, to turn it into a hub for container traffic between Africa, Europe and Asia.

"About 90% of the container volumes passing through the port are transit containers going to other destinations," Hawari said. He explained that West Africa is the largest market with a 40% share, an area where Moroccan companies have expanded extensively in recent years.

About 20% of the volume of containers goes to Europe and 10% to the Americas. Morocco invested about \$1.13 billion in building and equipping the first

quay, providing about 6,000 jobs at the port and another 70,000 in a commercial zone in the region.

The port is about 50km west of Tangier. The site allows room for further expansion. Tangier also has a ferry port that handles 40,000 passengers a day during the summer season. The new port is expected to reduce waiting times and to ease the traffic pressure on central Tangier.

Deputy General Director of the Tangier Port Authority Hassan Abkari said the port of Tangier serves regular passenger and cargo sea lines with the ports of Algeciras and Motril in Spain, Sete in France and Genoa and Savona in Italy.

Said al-Hadi, head of the board of directors of Tanger Med, said: "There is a significant margin for growth for the ports of Tangier and of Algeciras. Over the next 10 years, both ports together will be able to handle 16 million containers a year."

Experts said Tanger Med 2 has an excellent chance of becoming the number one port in the region, especially after being awarded an Eco-Friendly Port Certificate in March 2016 by the European Organisation of Ports, the first African port to receive the certificate.

The port is connected to more than 186 ports in more than 77 countries. It is near the Free Industrial Zone, where 900 companies operate in various industries, including the automotive sector, textiles, electronic devices, air navigation, logistics, food and other value-added businesses. The zone employs about 70,000 people and brings in \$6.2 billion a year in revenues, port management data stated.

Since its creation in 2007, the Port of Tangier has made great strides. Data show that, by the end of 2017, it received more than 51.3 million tons of cargo and about 3.3 million containers.

Yaouhi said it is necessary to expedite opening the port of Nador, west of the Mediterranean, to provide support and enhance integration with the ports of Tangier and the free zone in Kenitra.







Her performance in New Delhi and Kathmandu drew lot of appreciation. Here we are reproducing the translation (French to English) of an interview taken by Casablanca based Liberation magazine. The conversation is relevant in the wake of her scintillating performance in India and in Nepal, being organised by the Embassy of Morocco.

She does not intend to change her artistic line, to please a fluctuating market. She especially wants to take the path of an activist for universal love and transcendental passion. And for those who dwell on the clich "it's the public who chooses", it constantly replies with this image of the communion between Sufi song and the general public, everywhere.

From the sweet evenings of Ouarzazate to the beautiful gardens of the Oudayas, the same flavor and the same

fervor. How do you feel on stage?

First of all, I have the honor to take part in these artistic and cultural events. I am invited according to what I do, with poets and musicians. These are invitations that come from organizers of festivals and meetings that become aware of this type of art. All those who are convinced that poetry unites us to passion, can only love this expression.

What did you sing about?

For my participation in the various events this summer, it is mainly a real feeling to contribute to the proliferation of this kind of art, in the sense that I interpret not only songs, but a whole culture, a civilization and a mode of existence, a kind of interpretation of thought, love and sublime music. Thus, I interpreted some pieces of a work that I have just finished and which is based on

the poetry of Ibn Arabi and Ibn Zaydoun.

It is often argued that people's tastes have changed, and that the genre you sing is no longer fashionable. What do you think?

In any case, I will never be able to work on order. Everything I do comes from a deep inspiration and passion. I'm not there waiting for the orders of a "prefabricated" market, because I am indeed engaged in an experiment, well studied and which does not lack public. Just see how people welcome this kind of singing in Ouarzazate, Fez, Rabat or Marrakech or even in Paris and Brussels, to see the impact. This is not a job governed by supply and demand, it is above all a strategic cultural vision that has always inspired me and this quest will not stop. For me, Sufi poetry is a monologue, a dialogue and a breath that allows me to identify, mark and share this way of sharing.

Is it a choice?

Not even. I do not have to choose. It is a deep call at the inner level, and above all, it remains the work of an inspiration. There was first this participation in Fez, in 2000 and from there, I deepened my knowledge especially with our heritage of Samaa and beautiful poetry. I found an immeasurable pleasure in entering a world

where art is only part of a way of life. This is how permanent knowledge allows me to follow this extraordinary quest. I had sung Layla, a symbol of love and that Sufis borrowed to celebrate love, and I made Abou El Hassan Chouchtari, an Andalusian prince, whose poetry remains a rare pearl.

And research at the level of heritage?

The wealth is there, it's as if there is gold, but what are we going to do with it? Search or discovery is a permanent search for modeling. This is an interminable project that deserves the interest of many artists at once, and we will never be able to pin down it because we are facing a world of ideas and thinking. I do not get tired at all.

There are certainly some constraints, but they encourage me to do more. In fact, my experience was individual in production and work. So I have to do personal research and work technically my voice, because there are not really producers for this kind of art ... The market is moving more and more towards the commercial aspect.

This obviously remains difficult?

The word "easy" destroys the work to my knowledge. You should know that any project always requires construction work. Thorough and meticulous

research is required before beginning this phase of production. I do not find the way easy, but there is always this inspiration, this passion, this call that propels me to go forward. The effort and the suffering, the experience, the constraints are a wonderful springboard for any artist who knows how to put them on his side. The objective is to go to the end of oneself, each test must give more force for this fight.

When we sing love?

Elevation and transcendence deserve a song ... it is a call to the noble souls, to this part that every person has, it is enough to challenge and shake it ... We must transport the public towards a sublime knowledge, a high taste and quality craftsmanship. The culmination is this communion with the other and this renewable energy each time you sing and enchant a large audience. The artist also has a mission that must not be forgotten.

You are indeed in a universal thought?

Love is my nature, life, in general, invites us to more solicitude for good things. It is this return to the sources, to the truths that have always constituted the natural purity of birth. We must deal with everything that pollutes our spaces. We want this love to protect us. There is freedom in space, without being afraid to go to the peaks.

he Indian community has lived in Morocco since 1952. Till the late seventies, Indians mainly were in trading.

In recent times, as the Investment climate has improved and more welcoming to do businesses in Morocco, there is a change of perception and this has encouraged foreign businesses to invest in Morocco.

This change has encouraged many Indian companies to invest in Morocco for small size operations and bigger and more prominent industrialists to set up their manufacturing facilities in Morocco.

So, I would say that our diaspora in Morocco is growing and benefitting from the many advantages that they can obtain in Morocco. As you would know, that joint ventures have been set up in minerals, agricultural products, information and data systems, hotels to name a few.

The community is growing and we are now four generations of Indians present in Morocco

and this will hopefully continue. Indians have to see the possibilities of establishing themselves in Morocco.

We have strong cultural connections between the Indians and Moroccans and this can be widely seen through the presence of Bollywood films which have a strong impact for the Moroccans and this has been there since decades. Indians are respected in

Morocco and have blended into the Moroccan way of life.

How their presence is affecting the current economic and trade scenario of the country?

The economic and trade scenario, no doubt, is affecting to a great extent for both countries. Due to the various Indian investments in Morocco, this has helped Morocco in creating jobs, from the blue-collar to the white collar of Moroccans who are in need of these opportunities created.

The know-how in various fields which India offers has created a good economic climate and this has been welcoming and encouraging.

Excluding the trade between India and Morocco in phosphates, there are improvements, though not as expected. I would say that this can be improved and changed if we can convince the Moroccan policy makers to open up preferential trade possibilities such as removing tarif barriers, facilitating visa free entries for businesses, simplifying investment procedure, opening up

trade routes through direct airline connections and so on.

This should be mutually beneficial to develop the economic and trade of both countries. Today, I would say and as far as I can estimate, there are more than 1,500 Indians, either working or in higher administrative postings.

The main Indian industries established in Morocco since the past five years are: Varroc Lighting Industries, Sumilon Pet, Indore international, Onshore Construction, Furnace Fabrica,

Satguru Travels, GFL GM Fluorspar, Sunpharma, Varun Beverages, Imacid, Tata Motors, Cipla Limited, Larsen and Toubro, Sterling and Wilson and Oberoi Hotels.

India and Morocco had launched the India-Morocco Chamber of Commerce and Industry (IMCCI) in 2016 to accelerate the pace of economic development between the two countries.

The chamber was jointly launched by the then Vice President, Mr. Hamid Ansari and the then Moroccan Prime Minister, Mr. Abdelilah Benkirane.

Speaking on the occasion, Mr. Ansari said that a Chamber of Commerce and Industry did not exist because "we took things for granted". He said that the world is changing and it has become a globalised world. "We do need bodies like the IMCCI," the Vice President had added.

Meanwhile, IMCCI has organised following events, to boost business, investment, profit and new jobs. Some of the key events held;

Catalogue exhibition for the Bengal Global Business Summit on 06 January 2017 at Hotel Golden Tulip Farah in Casablanca; Catalogue Exhibition for Momentum Jharkhand on 15th February 2017 at Embassy of India. Morocco Highlights on Fighting Terrorism, Humanizing Immigration and Protecting Human Rights

The Kingdom high points in fighting terrorism

Morocco remains a land of welcome, hospitality, openness and cohabitation and a peaceful country that works to promote the culture of peace and stability. The Kingdom is characterized by its singularity within its geopolitical environment, in terms of democratic choice, openness to the world. The Kingdom is distinguished by its exemplary experience in the fight against terrorism and extremism and its tangible efforts to reform the religious field in order to protect the Moroccan society against the risks associated with the ideological instrumentalization of religion. Because of its geographical position, Morocco is at the heart of regions affected by many factors of instability, but it is and will still remain safe:

- The rise of terrorism and violent manifestations of extremism, as well as the spread of the terrorist nebula, particularly in Africa;
- In 2018 alone, there were 327 terrorist attacks in North Africa, including Libya; 98 terrorist attacks in the Sahel region and 487 terrorist attacks in the rest of West Africa [source: Global Terrorism Index];
- A dozen (active) terrorist groups have been identified in the Sahel in 2018, compared with only one in 2010 [source: Center for Strategic Studies of Africal.

These factors are all the more alarming in that they operate in a context of fragility, marked by the proliferation of conflicts, the proliferation of non-state actors threatening the sovereignty and territorial integrity of states, the rise of illicit trafficking of all kinds, and forced displacements of populations. Starting from the observation that the deterioration of the security situation in some countries represents a real obstacle for the future of the whole neighborhood, Morocco does not lose sight of these regional realities in the implementation of its efforts to fight against the threats both bilaterally and multilaterally.

The Kingdom has been committed from the very beginning to act voluntarily for the establishment of a lasting stability at global, regional and sub-regional levels through the adoption of a global approach based on an integration, in a coherent and complementary way, the security dimension, necessary but insufficient on its own, economic growth and human development, as well as the preservation of cultural and cultic identity.

Hence, Morocco's approach is cooperative, inclusive and based on the values of openness and integration of all actors aspiring to achieve the objective of eradicating terrorism. Morocco has made the strategic choice to promote solidarity-based South-South, North-South and triangular cooperation, which translates into the realization of concrete projects with several countries in areas essential for stability and human and sustainable development.

Morocco is investing not only in the military training of many brotherly African countries, but is also working for greater regional

and sub-regional cooperation through the sharing and exchange of intelligence, the deployment of teams to assist and guide local services, training and introduction to intelligence techniques, provision of logistics and the organization of exercises and operational programs.

The Moroccan approach is complemented by proactive actions promoting prevention, such as the strengthening of infrastructures and institutions capable of responding to the underlying causes of violent extremism that may lead to terrorism, such as poverty and social precarity.

In this context, Morocco multiplies agreements with sister African

countries (1526 cooperation agreements), the very essence of which is the emergence of a sustainably stable and prosperous Africa.

Morocco is also involved in setting up platforms for the exchange of expertise and mutual enrichment in terms of development and human investment. In 2017, a committee was formed to establish a common roadmap to develop training, promote the exchange of good practices and share successful development models between Morocco, Senegal, Central African Republic, Cameroon, C te d'Ivoire, Chad, Benin, Burkina Faso, Comoro Islands and Congo.

The Kingdom's humanitarian approach to migration

Morocco is party to several international instruments of human rights, migrant law and international refugee law. The Kingdom was among the first countries to join the international awareness of migration issues by ratifying in 1993 the International Convention on the Protection of the Rights of All Migrant Workers and Members of Their Families, of which it was, also, promoter.

With a long experience in the different aspects of migration, the Kingdom is actively engaged in all Regional and International Consultation Processes on Migration (High Level Dialogue on Migration and Development, Valetta Process, Process Rabat, 5 + 5 Dialogue, Global Forum on Migration and Development and the Global Compact on Migration).

On the national level, since 2013, Morocco has had a national immigration and asylum policy, based on a humanist approach, in line with Morocco's international commitments and respectful of the rights of immigrants. Morocco also adopted, in December 2014, a national immigration and asylum strategy based on the socio-economic integration of immigrants. The implementation of this new immigration and asylum policy has materialized by the:

- Continuation of the upgrading of the legal and institutional framework for Asylum and Refugees and the fight against trafficking in persons;
- Measures to promote the socio-economic integration of migrants in the Moroccan society;
- The fight against trafficking networks of human beings.

Two exceptional regularization operations adopted by the Kingdom for sub-Saharan

immigrants, in an irregular administrative situation, in the national territory, took place in 2014 and 2016, which benefited 50,756 migrants, 23,464 of whom obtained a residence permit. As part of the implementation of the High Royal Guidelines on the new national immigration policy, the Government has drawn up an operational plan of action around the following four essential axes: The situation of refugees and asylum seekers; the question of foreigners in an irregular administrative situation; the fight against trafficking in persons and the improvement of the conditions of foreigners in a regular situation.

At the continental level, the nomination of His Majesty Mohammed VI, the King, as a Pan-African leader on the issue of migration, is making the Kingdom an active and committed defender of African interests both regionally and internationally. At the 30th Summit of Heads of State and Government of the African Union (AU), in January 2018, His Majesty the King, African leader on the issue of migration, presented a report for an African Agenda that considers migration as a factor rapprochement between peoples and civilizations and tends to make migration a lever for co-development, a pillar of South-South cooperation and a vector of solidarity.

During its June 2018 session, the AU Peace and Security Council adopted the proposal of His Majesty King Mohammed VI as African Leader on the issue of migration, settlement and an African Migration Observatory, to help realize the commitments made in migration management and to contribute to the formulation and implementation of policies implemented at the continental level.

At interregional level, as part of the follow-up to the implementation

of the Rabat, Process, Morocco hosted the 5th Ministerial Conference of the Euro-African Dialogue on Migration and Development on 1st and 2nd May 2018 in Marrakech. This Action Plan aims at maximizing the positive impact of regular migration on development in

165 governments. The Marrakech Agreement was adopted by the General Assembly of the United Nations on December 19, 2018, by 152 votes for, five votes against (United States, Hungary, Czech Republic, Poland and Israel), and twelve abstentions.

Thus, on issues of populations'

the Rabat Process region and aligning this Action Plan with the priority areas of the Valletta Framework, in particular with regard to deals with irregular migration, protection and asylum, trafficking in human beings and return and readmission.

At an international level, Morocco has made the integration of migration into its development policies a priority. In this context, the Kingdom chaired the 11th Summit of the Global Forum on Migration and Development that took place in Marrakech from 5 to 7 December 2018.

Morocco also hosted the Intergovernmental Conference for the Adoption of the Global Compact for Safe, Orderly and Regular Migration on 10th and 11th December 2018 in Marrakech, which culminated in the adoption of the Marrakech Agreement by representatives of

mobility, Morocco moved from being a country of emigration and passage to Europe, to becoming an immigration area with regularization of an important number of sub-Saharan migrants.

The Kingdom protecting human rights from the North to the South

Human Rights are one of the three pillars of the UN Charter. Since the adoption of the Universal Declaration of Human Rights in 1948, the international architecture of the Human Rights regime has grown exponentially by the creation of the Commission on Human Rights that was replaced in 2006 by the Human Rights Council, the expansion of the Office of the High Commissioner for Human Rights, the special procedures and the treaty bodies. Morocco has both invested heavily in its National Human Rights Institutions because it is

conscious of the fact that this century is going to be the century of Human Rights.

Under the Reign of His Majesty, the Royal Decree Establishing the National Human Rights Council in its first article sets the tone by setting a dual system of Human Rights protection and promotion both at the national and regional levels. Therefore, the thirteen Regional Commissions on Human Rights covering the entire territory of Morocco are entrusted with the responsibility to promote and protect Human Rights at the local and regional levels while acting under the aegis of the National Human Rights Council.

In the case of Morocco, the National Council for Human Rights is a national pluralistic and independent institution, created by the Royal Decree no. 1-11-19 of 1 March 2011 to deal with all matters in relation to the protection of human rights and freedoms, in accordance with national and universal norms in this field. It is the National Human Rights Institution (NHRI) of Morocco that benefits from the "A" status of the International Coordinating Committee which reviews periodically the grading of NHRIs across the globe. This "A" status comes in full recognition to the full degree of autonomy that the CNDH of Morocco enjoys. Having replaced the former Consultative Council for Human Rights, this institution's main tasks are the observation, monitoring and follow up of the human rights situation across the Kingdom.

In this context, the Council reviews all cases of human rights violations, either on its own initiative or on complaint of concerned parties, and carries out necessary surveys and investigations whenever it has confirmed and reliable information on these violations, whatever their nature or origin

could be. Within the framework of its mission of human rights monitoring in all of the Kingdom's regions, the Council may interview anyone whose testimony may shed light on a situation of infringement or alleged violation of human rights. Furthermore, the Council may serve as an early warning system, in coordination with relevant public authorities, in any delicate situation likely to cause human rights violations, by deploying all necessary mediation or conciliation means that may prevent the occurrence of such violations.


As a national institution, the Council is also tasked to visit detention facilities, prisons, child protection and rehabilitation centres as well as places of detention of foreigners in illegal situation. It has, moreover, to study the harmonization of laws and regulations with international treaties on human rights and international humanitarian law to which Morocco is a State party. In addition, it helps with the elaboration of national reports submitted to treaty bodies and international organizations, and encourages the Government to apply their final observations and recommendations. It contributes also to the observation of electoral operations. In fulfilling its attributions, Regional Human Rights Commissions are attached to the Council. Those Commissions are in charge of ensuring the protection and promotion of human rights, both at local and regional levels, and receiving complaints in relation to alleged violations of human rights.

Therefore, the Moroccan proposal is part and parcel of a process of global and in-depth democratic reforms gradually but irreversibly launched in the 90's in order to strengthen the rule of law and regionalization throughout the national territory. With the creation of administrative regions

and enhanced regionalization, the Moroccan autonomy initiative is indeed a qualitative leap in Morocco's decentralization process. Moreover, Morocco's CNDH became a constitutional institution in 2011. Article 161 of the Moroccan Constitution provides that "the National Council of the rights of man is a pluralist and independent national institution, charged with taking cognizance of the questions related to the defence and to the protection of Human Rights and freedoms, to the guarantee of their full exercise and of their promotion, as well as the preservation of the dignity, of the individual and collective freedoms of the citizens, and this with strict respect for the national and universal referents in the matter. In terms of regional powers, the CNDH has thirteen regional human rights commissions, among which two of them are in Dakhla and Laayoune, in the Moroccan Sahara.


A review of the Moroccan positive law shows that in terms of provisions related to the rule of law, in terms of human rights and good governance, Morocco has nothing to envy to established democracies. Morocco is a party to a number of international human rights treaties, particularly the International Covenant on Civil and Political Rights (May 3rd 1979), the International Covenant on Economic, Social and Cultural Rights (May 3, 1979), the Convention on the Rights of the Child (June 21' 1993), the International Convention on the Elimination of All Forms of Racial Discrimination (December 18th 1970), the Convention Against Torture and Other Cruel, Inhuman or Degrading Treatment and Punishment (June 21st 1993), the Convention on the Elimination of All Forms of Discrimination Against Women (June 21st June 1993).

Art and Crafts: The Creative Minds of Moroccan Sahara

proven way guaranteeing the success of small enterprises in the social economy consists of bringing out the value of their local know-how. The arts and crafts appear as a source for a variety of sustainable jobs in the long-term, in view of the diversity of their products and their centuries-old tradition. But this sector relies on the craftsman himself, as the quality of his products and the extent of his know-how can be arbitrary - both vary from one person to another - in the absence of manufacturing standards.

of tatoui ceilings, which are made from a muddle of bay tree wood painted in scarlet, was on the verge of being lost, until the last masters of this art were identified, who trained dozens of apprentices, now working in specialized cooperatives, and who are more and more solicited for the building of dwellings.

It was then necessary to make craftsmen comfortable in their traditions, to make it known that the red carpet with camel hair fringes has always been part of Sahara identity, to revive the cooperatives that wave *flij* by encouraging them to take orders

To strengthen this sector of the economy, it has sometimes been necessary to resurrect a disappearing art. The production for tents made out of goat hair, so as to replace the tents for official gatherings made out of other fabrics, to ensure that cooperatives

use only the finest raw materials for the crafts that they traditionally produce out of leather (tasoufra, kauntya, assermi...), and to

teach new braiding techniques to the members of cooperatives specializing in basketry.

In all the Southern provinces of the Kingdom, dozens of cooperatives, jewelers, basket-makers, tapestry weavers, leather craftsmen, have been brought together, equipped, even taught in their profession, and they abide by a very high standard of quality. This involves taking training classes, and the latest trend is to connect craftsmen and designers, so as to enrich the portfolio of products with new, modern designs, or just to create new products for new uses. Sometimes, a simple idea can help improve a products appeal, as it is the case of the traditional tents, which are now produced in different standardized sizes (kits), and are easily dismantled, as the tent's framework has been improved to be more malleable.

"New craftsmen" have also appeared recently, as in the case of this cooperative made of ten people founded in the city called Es-Semara for the production of wooden crafts, like the fruit bowls, other traditional bowls (gdah), and even the sigh game



(very popular; resembles pick-up sticks).

Once the members of the cooperatives have been taught the latest arts and crafts techniques and have been trained on to manage their production, they are then organized in economic interest groups, able to take a large amount of orders, as is the case of basketry at the city of Tata, where the craftsmen are now able to take large orders for mats, baskets or bassinets.

At Fam EI Hisn, an oasis known for its merchants selling silver

jeweller, a "Metal house" is built, made up of workshops provided for the production of the jewels, as well as an exhibition hall which serves as a retail store.

Other market niches are also being researched, for example, the creation of cooperatives for the production of traditional outfits, in Laayoune. The patenting of a brand, exclusively for the arts and crafts of Moroccan Sahara is also being considered, so as to facilitate the development and structuring of this sector in a fairtrade network.





Development in the Skies for the Southern Provinces of Morocco

he flight time from the Southern provinces of the Kingdom to the Mohammed V Airport in Casablanca is a matter of hours, and let us not forget that Rabat, the capital, is about an hour North of Casablanca by car, which means that to get to Rabat from the South, well... that's quite a trip!

The infrastructure development is completed: at the airports of Laayoune and Dakhla hundreds of thousands of passengers land and take off each year, Tan Tan has an air terminal, and Guelmim an airfield. But the flight distances travelled are huge and the number of passengers on each plane is not enough to yield a profit such as ensuring a rotation frequency that matches the investments made in the Southern provinces of the Kingdom. Because managing an airline is a matter of costeffectiveness, and its profitability is



ensured only when the destination is already well developed, while the development itself relies on accessibility.

In order to break this vicious cycle, an original government subsidiary

system has been the solution for nearly a decade, guaranteeing the airline companies that they will reach the minimum profit threshold, while selling airline tickets at accessible prices to the average traveller.





The results followed immediately: the number of flights to the Southern provinces doubled in the first years (from 2003 to 2006), until flights to Laayoune and Dakhla reached a daily occurrence, and flights to Tan Tan and Guelmim became available five days a week, with flights during appropriate hours of the day. The neighbouring Canary

Islands were not omitted, given that Guelmim, Laayoune and Dakhla are close by, and soon flights to these islands were available weekly, or even daily, thanks to the same system of guarantees subsidizing air transportation.

Could Laayoune become the economic metropolis of the


South? Could Dakhla become an international holiday destination? What about Tan Tan and Guelmim, the gates to the Azur Plan tourist stations? This is not a vision of a future paradise, but more and more a reality, one that is two hours away from Casablanca.



he territory of the southern provinces is huge (58% of the kingdom surface area), and from this eternal immensity springs diversity...

Resources and production of the oasis world and the Saharan world come together in a vital and harmonious complementarity, just like the one between nomads and sedentary people from the Moroccan Sahara. Today, a through inventory of resources and expertise has allowed the

identification of hundred local products. Indeed, this unique heritage has a great potential to establish a strong social economy, which will favor private initiative and enhance local and regional identity. Thus the South Agency (The Agency for the Economic and Social Promotion and Development of the Southern Provinces) and its partners have launched a major program to structure and emphasize these ancestral resources.


More than 100 production units exist today. The beneficiaries are more than 250 associations or cooperatives. They have been trained, supervised and accompanied in productive specializations taking into account the specificities of the geographical area, in a vision of a sustainable territorial development. These units have all been brought up to the highest standards, establishing detailed specifications and a certification and labialization

process is ongoing, or already achieved, for many of them. From a quantitative and qualitative perspective, the structuring phase of these units into about twenty sectors, dedicated to food and cosmetics, was decisive for production.

Concerning the local Sahrawi products, it has more to do with arts of living, but it also clearly refers to an anthropological dimension of the Saharan-Hassani culture. These local Sahrawi products, camel meat and meat products, camel milk and camel milk products, dates, daghmouss honey and other plants, multigrain khoumassi couscous, henna, cactus and cactus products, aromatic and medicinal plants etc. have already been identified. And they also have been structured into sectors

and enhanced through a network of cooperatives. However, they still need to be developed as part of a tourism development strategy, focusing on lifestyle' specificities (living in tents, nomadism, oasis world). Within the region, some products have gained such a significant reputation that they can travel thousands of kilometers to meet their consumers.

The geography and the environment of Sahara is difficult and challenging. When certain provinces from the Southern Region were integrated into Morocco the economic and development situation was very



The development of the Southern Provinces is being implemented by direct intervention of the State of Morocco. It was in year 2002 that King Mohammed VI decided to create - Agency for the Promotion and the Economic and Social Development of the Southern Provinces of the Kingdom.

This Agency now interacts with the locally elected representatives from the Southern Region.



Located in fragile ecosystems, the Southern provinces did not return to the Mother homeland until 1975 after the historical Green March architected by the late King of Morocco Hassan II. At the time, the level of human development in these territories was lower than the national level with a human development indicator that did not exceed 0.4. More than 50% of the population was below the poverty line.

Forty-four years after 1975, we are witnessing a reversal of trends and

bad. The poverty ratio was 50 percent. The Government of Morocco after the integration was obliged to provide the same level of development as in the North.

From the Green March of 1975 and till today we are engaged in economic development of the region. We at the agency and other public institutions have been focusing on providing electricity, water, communication, transport and job opportunities for the local population. The critical issues of health and education are also being developed by implementing several economic projects.

*

these regions are ranked first in the ranking of Morocco's regions in terms of human development with a Human Development Index (HDI) of 0.641 against 0.612 as an average at the national level. The same trends are observed in terms of access to basic services. The gross education rate is 81.8% compared to 74.9% nationally. The Gross Domestic Product (GDP) per capita is increasing by 5.8% per year and the poverty rate was around 3.5% in 2011 compared to 6.2% at the national level.

These advances are the result of the efforts made by the Government, the elected bodies and the civil society according to a voluntarist approach. In fact, the three Southern regions of the Kingdom are the first recipients of social assistance and the third beneficiaries of annual public investment in the Kingdom at 1.5 times the national average.

The efforts of development actors are multidimensional and concern all sectors and territories and especially cities, given the high rate of urbanization which is about 77.3% at the level of the three regions against 3% at the



national level. This rate reaches 93.4% in the Laayoune-Sakia EL Hamra region.




The different Urban Development Programs were conducted using a participatory approach involving elected officials and civil society in the decision-making process from programming to implementation. In addition to the physical achievements, this approach allowed the transfer of competences to elected bodies.

This approach has also been adopted at a more strategic level to define the New Southern Provinces Development Model which concerns the three regions, namely Laayoune Sakia El Hamra, Dakhla Oued Eddahab and Guelmim Oued Noun. This model is the result of a national debate involving all actors at national, regional and local levels. This program, launched by His Majesty the King, may God Assist, and amounting to 77 billion

dirhams, includes structuring projects that will inject a new dynamic into the development process.

The dual route, the Atlantic port, major agricultural projects, the construction of fishing villages, the connection of Dakhla to the national electricity grid, the drainage of private investment, the production of clean energy, the strengthening of the university and medical offers are among the projects being implemented as part of this ambitious program, carried out as part of wider regionalization.

As an indication, in 1974 the number of inhabitants in Laayoune was 12,152. From 1975 this city has experienced an unprecedented boom and is currently the main

pole of economic growth in the Southern regions of the country and is home to 31.3% of the population representing the first major city in the south of the Kingdom. This importance, this city owes to these structuring equipments such as the port of Hassan lst, the port of Laayoune, the technology park of Foum El Oued as a center of academic influence, its cultural and sports infrastructure including its library and its theater in progress as well as its offer of professional training and higher education, which will be reinforced by the creation of the Faculty of Medicine and the University Hospital.

The development of the city of Boujdour is also among the most spectacular. A village consisting of

a lighthouse and some buildings at the time of recovery of the Southern provinces, Boujdour then quickly developed, taking advantage of its position connecting Laayoune to Dakhla. Maritime fishing, at the heart of the city's economic activity, received a decisive boost with the construction of the new port and administrative district.

These two cities were declared cities without slums in 2008, like the city of Dakhla, thanks to the various programs led by the public authorities, the last of which is the city of Es-Semara for the permanent eradication of unsanitary housing in these areas of the Kingdom.





OCP Foundation in India

Ten Years of High-impact Social Action



ccording to its mission in supporting and promoting positive community dynamics, OCP Foundation actions go beyond the borders of Morocco and extend to international communities. It commits to strengthen South-South cooperation and meets the needs of local populations.

OCP Foundation has launched several major projects in India. Since 2010, the Foundation has been supporting small farmers in nine Indian States in carrying out integrated agricultural projects.

Through a partnership with local contributors, the projects launched by OCP Foundation have boosted small farmers' yields and improved their living conditions by providing them with solutions to social, medical, and women's empowerment issues.

Among other things, the projects have made possible in improving beneficiary farmers' yields of cereals, legumes and vegetable crops.

As an example, the results of the

impact study of the agricultural extension project in Karnataka show that the average annual income of the beneficiary farmers has tripled from less than 1,000 USD in 2009 to over 3,500 US\$ in 2018. The projects have also made possible partnerships with the country's universities. Improvement of the beneficiaries' living conditions

As part of South-South Cooperation, OCP Foundation has launched a rural development project in the State of Karnataka.

In collaboration with the National Institute for Agricultural Research of Morocco (INRA) and the Indian Society of Agribusiness Professionals (ISAP) in India, OCP Foundation deployed the Agricultural Extension Services (AES) project in 2010 in Gulbarga, Bidar, and Raichur districts of North Karnataka. Its main goal was to set up an agricultural extension program to directly support several thousand-smallholder farmers. AES has

substantially improved small farmers' yields and incomes.

After the official closure of the OCPF-AES project in Karnataka, the presidents of all the existing Farmer Producer Organizations (FPOs) came together in what then came to be known as the Karnataka Farmers Maha Society (KFMS) that aims to bring farmers together and ensure work continuity.

The KFMS started procuring tur (red gram) from places such as Aland, Afzalpur, Ankalga, Raichur and Bidar. Under the Red Gram Procurement under PSF (Price Stabilization Fund), they supplied 288,748 quintals of red gram to the National Agricultural Cooperative Marketing Federation of India Ltd. (NAFED), an approved purchasing organization, for an average cost price of 5,050 rupees per quintal.

11,500 farmers benefitted from this endeavour. Moreover, the Karnataka State Government gave all the beneficiary farmers a bonus of 450 rupees per quintal, so that amounted to an additional 12.99 rupees crore.

In addition to these measures, KFMS has also set up Farm Machinery Custom Hire Service Centers that give small and marginal farmers, who cannot afford to purchase Farm Machinery, the opportunity to avail farm machineries like combine harvesters tractors, rotavator, seed driller etc. at nominal charges at their door step.

In addition, KFMS has facilitated access to emergency medical services for farmers in rural areas. They are now able to provide emergency medical care to persons who had suffered sudden or serious injuries or illnesses. Access to emergency services is crucial for people living in rural areas where access to first aid is generally difficult.



Empowerment of women in agriculture

As part of the Integrated Farming System (IFS) project launched by OCP Foundation in association with ISAP in three districts of Rajasthan, many women were brought together to form Self Help Groups (SHGs). These groups later on amalgamated into what later became the Shree Dev Mahila Kisan Producer Company Limited in 2017 with the primary goal of expanding women's livelihoods opportunities. The beneficiaries were at the forefront of the Farmer Producer Organization (FPO), an entity that is ultimately solely made up of women.

With the project coming into their lives, they started attending meetings, and being able to speak







up in those meetings and share their opinions has allowed them to collectively try to come up with solutions to their daily problems. Gradually, the beneficiaries formed their own SHGs and later many of them became board members of the FPO.

Thanks, in particular to the IFS project, women were granted the right to occupy certain decision-making positions in the public and private sectors, thus putting an end to their lack of involvement in public, family, and even community debates.

Impacts on the agricultural sector

India has undertaken ambitious reforms for the benefit of farmers. The will of the political authorities combined with initiatives such as those launched by OCP Foundation are boosting farmers' income growth forecasts and those in terms of improved living conditions.

9,600 agricultural beneficiaries

In February 2016, Indian Prime Minister Shri Narendra Modi, while addressing a rally, set a goal to double farmers' income by 2022-2023 in order to promote farmers' welfare and bring parity between the income of farmers and those working in non-farm sectors.

Achieving this goal will require compounded annual growth of 10.4% in farmer income between now and 2022. Moreover, the Government of India is considering the following key interventions aimed at increasing farmers' incomes: irrigation, quality seeds, soil testing, post-harvest crop





Improving the Agricultural Value Chain

OCP Foundation contributes to disseminating knowledge through its commitment to providing a better world for future generations. OCP Foundation is structured around several areas such as education, training, and R&D.

It pursues its engagement and implements its programs through a participatory approach with public and private partners in Morocco and in several countries of the Southern Hemisphere. This approach allows it to instill a positive momentum within communities thereby making it possible for the entire environment to progress for a just and equitable future.

As part of its programs to support local populations at the international level, OCP Foundation works alongside its expert partners to implement socioeconomic projects through the improvement of the agricultural value chain.

- Research & Development and technology transfer: developing and improving crop management techniques;
- Empowerment of small farmers: capacity building, providing access to agricultural mechanization and promoting agribusiness;
- Digitalization of the National Office of Agricultural Council: implementing call centers and mobile applications;
- Structuring and organization: creating cooperatives and Economic Interest Groups (EIG).

losses, value addition to farmers, new crop insurance scheme and promotion of ancillary activities.

To this end, OCP Foundation's project has undertaken in India in partnership with ISAP is highly relevant as it aligns with Prime Minister's vision of "New India." The OCP Foundation-IFS project in Rajasthan promotes a balanced approach towards strengthening the agricultural value chain and improving farmers' livelihoods. The project was conceptualized and designed jointly by a team of experts from OCP Foundation and ISAP and senior agricultural scientists.

The Integrated Farming System project started in 2014 and has been implemented in three districts in South-East Rajasthan: Sawai Madhopur, Bundi, and Baran, covering six development areas. This project aims to increase productivity of field crops and maximize the resource base of the area for overall improvement in production income and diversification of farming practices in the project geography.

More than 9,600 farmers are directly

benefitting from the project and contributing to it. The expected improvement has been achieved through the implementation of improved crop production technologies, integrated farming system (IFS) and resource conservation; namely, water harvesting and farm management, recycling of natural and agricultural resources, as well as by generating farm level resource base like

vermi-compost, bio-pesticides and value additional farm gate. An innovative approach has been adopted to constitute and promote small farmers' production and agribusiness organizations with linkages to marketing and value chain stakeholders.

Digitalization of agricultural practices

One of the innovations launched by the OCPF-IFS project is Krishi Gyan, the Android mobile application-based decision support system (DSS) for extension agents. This app helps extension agents/farmers in diagnosing disease and/or pest infestations in the project farms and offers control measures.

The application also contains information on proven cropping techniques through an animation video. It additionally provides local weather information and allows extension agents and farmers to consult experts from a call center set up as part of the OCP Foundation's Kisan Call Center (KCC) project. The app is also available on Google Play and has been downloaded over 40,000 times to date.

Furthermore, it enables extension agents/farmers to consult with KCC experts.

Al Moutmir: OCP Model to Better Serve Farmers

s part of its commitment to a gricultural transformation, OCP Group has set up a multiservice outreach initiative to better support and serve the farmer in September 2018. Called "Al Moutmir," which means fruitful, this agile and integrated initiative reflects OCP's commitment to help transform the agricultural sector.

Al Moutmir is based on three main pillars: the scientific approach, to ensure a sustainable supply, the partnership approach, to jointly establish innovative agricultural development models through the participation of stakeholders in the agricultural sectors, and farmers themselves as real agents of change through the implementation of a capacity building program aimed at farmers, women, cooperatives, and young leaders. The initiative comprises many services, including mobile soil testing laboratories that travel throughout the Kingdom in order to test soils directly on

farms, a training offer on all crop management techniques given by the Al Moutmir team with institutional partners, and demonstration platforms that help with training on agricultural best practices. The Al Moutmir initiative also includes a best-inclass digital and technological offer that includes a mobile application called "@tmar." It features a range of assistance and technical support services for farmers such as climate data, fertilizer recommendations, farm







management operational advice, profitability simulators, and market information on agricultural product prices. This application is available to all farmers free of charge.

The offer also includes the services of the smart NPK Blend fertilizer production units (Smart Blender) that produce custom fertilizers. These production units use soil analyses and target yields to produce fertilizers tailored to each crop and soil type.

This initiative is carried out by over 60 agronomists deployed across over 40 provinces in Morocco and work daily with farmers, providing them with training, demonstrations, monitoring, and support.

A strong impact on farmers

In the short time since its inception, the program has had a major impact on the agricultural world, reaching 10,000 farmers, including more than 1,000 women. In total, over 10,000 soil analyses were carried out in the mobile laboratory and in laboratories at the Mohammed VI Polytechnic University.

Al Moutmir has also made it possible to launch 2,000 demonstration platforms, including 1,000 for cereal and legume crops, 700 for olive trees, and 300 for fresh produce.

In addition to the training component, Al Moutmir is capitalizing on the momentum generated by the Act4Community

initiative by launching Act4Farmers, an initiative that allows volunteer OCP employees to implement actions that help farmers in different regions of the Kingdom. Volunteer employees are given the necessary tools to better help farmers with the support and expertise of agronomists, exhaustive scientific documentation for each crop, the Al Moutmir mobile unit, mobile laboratories, demonstration platforms, and training.

Technology is at the heart of Al Moutmir

Using digital technology, Al Moutmir intends to heighten its impact on farmers by increasing its reach, making its various services accessible and capitalizing on its achievements.

We can also mention Agridistributors, a software used to manage the relationship between OCP and its partner-distributor network.

Agripedia is a digital platform that compiles OCP's agronomic knowledge for the benefit of farmers, agronomists, and OCP employees interested in agriculture. With a single click, users can access detailed scientific information on different crops according to their needs. Educational materials are used to make sharing best practices easy (instructional videos, graphics, technical guides, etc.).

Agritrials is an application that uses digital technology to manage

demonstration plots and provides real-time descriptive information on plant phenology and any threats they may face. It makes it possible to capitalize on demonstration platforms by providing a database that can be shared with the agricultural ecosystem with a view to exploring innovative models capable of fostering the emergence of prosperous and sustainable agriculture.

@tmar is a multiservice mobile application developed by the OCP team to better support farmers.

It includes a wide range of services available to farmers free of charge, including weather information, plot monitoring, profitability simulators, and international agricultural market updates.

In a spirit of sharing, OCP intends to replicate this model in other countries or on other continents that are experiencing a similar agricultural transformation.



Around 40 journalists and food bloggers attended the event.








20th Anniversary of the Enthronement Celebrations in Nepal

Simplification of Business Visa Procedure Between India and Morocco

External Affairs Minister of India to Morocco on 17th - 18th February, 2019 and signing of Memorandum of Understanding between the Government of the Republic of India and the Kingdom of Morocco, on the reciprocal facilitation of procedures for issue of Business Visa, it has been decided to implement the same from 01 April 2019.

Salient features of the agreement are as follows:

- Each party shall issue business visas with multiple entries valid for a period of 12 months to visitor investor of the other country, on a case to case basis, who submits a request letter issued by a company duly recognised by that Party; a Chamber of Commerce and Industry, business and trade promotion council or business organisation duly recognised by that Party.
- Business visa seekers would be required to submit necessary documents, in accordance

- with the visa regulations, in addition to, as appropriate, notes verbales, official letters or letters of approval or invitation letters along with applicable visa fees;
- Business visas will be granted in seven (07) working days as far as possible, from the date of receipt of all required documents;
- Business visa holders would be required to register themselves with the competent authorities in case the aggregate stay on Business visa exceeds 180 days during a calendar year.

"Morocco and India Have Many Similarities in Music"- Haj Youness

The Moroccan artist and lute player, Mr. Haj Youness made his ninth trip to India. On the occasion of 20th Anniversary of the Enthronement of HM King Mohammed VI, following his performance in New Delhi and Kathmandu, he gave an interview to Journalist Harun Riaz. Awarded with Lute d'Or (Golden Lute) in 1983 by late King Hassan II, following are the excerpts of the conversation;


How did you become a Lute player in Morocco?

You know when you are a child, interests and hobbies develop. My interests in musical instrument happened because of my childhood friends. As I was growing up my liking for playing Lute happened. Lute is made from wood and is like the belly of a duck. Lute is also more rich than the western guitar. The instrument offers more space and provides more depth, while playing it.

You have travelled to India nine times and performed at various locations and settings. What has been the response of the Indian audience and understanding, to your musical performance?

Firstly, the love and affection shown by Moroccans for India is enormous. I was influenced by Indian movies made by Raj Kapoor, Shammi Kapoor and others. The songs and music of popular Hindi movies were learnt by heart. In my childhood I watched Hindi movies.

As an artists I have travelled to more than 45 countries worldwide, but affection, warmth and appreciation shown by the Indian audience is special. The audience here appreciates music, culture and performances by musicians. I strongly feel that there is a certain rhythmic fusion which is unique to Morocco and India.



Can you tell us about the interest in arts and culture among the young generation of Moroccans? What about music curriculum at school and college level? And is the advent of modern technology making youth go away from traditional forms of art and culture?

On the contrary, the digital technology has in fact, popularised traditional art and culture more than the legacy media. Facebook, YouTube, Instagram, Google and Twitter have tremendously increased the reach of our arts. You just enter the name of any artist and you get all the details in seconds on world wide web.

In Morocco, we have special classes for artistic education including in smaller cities. How to play an instrument, how to sing, paint, perform etc. Our arts and culture are centuries old, have deep roots and modern technology

or the western influence will fail to prevent its continuity, growing popularity and fusion with other countries.

How difficult or easy it is to make a career in the field of music in Morocco?

Let me inform readers that I am also a Professor to teach Lute in Morocco. I was also the Director General of all the concerts (total nine), and my office was based in Casablanca. At the same time, Morocco has some of the most talented artists today including Lute players. It is with happiness I can say that Lute as a musical instrument is as popular as ever.

HM King Mohammed VI gives lot of support to arts and music. Two big opera houses are being constructed in Casablanca and Rabat. Once operational, these will give lot of opportunities to the young Moroccan artists.


